Special Terms and Conditions for the Go Paperless and WIN Prize Draw Competition.

Who is the promoter?

How does a person get an entry in the promotion or competition?

IMB members who hold an IMB deposit account and are 13 years of age and over are eligible to enter the competition. The entrant must register for eStatements within IMB's Internet Banking during the Promotion Period.

Residents of which State(s) or Territory(s) qualify?

This competition is open to NSW, ACT and VIC residents.

What does a person need to do once it is established, they are eligible to enter the draw?

IMB members who hold an IMB deposit account and receive paper statements at the beginning of the Promotion Period are eligible to enter the competition. The entrant must register for eStatements within IMB's Internet Banking during the Promotion Period by changing their statement preference to 'Online'. The entrant will then automatically receive one entry into the competition.

Times and dates when entries open and close:

Entries open 9:00am Wednesday, 1st July 2020 and close 5:00pm Friday, 28th August 2020 (the "Promotion Period").

Value of Prize/s:

\$1,000 deposited into the winning entrant's deposit account within 30 days of the draw.

Time, Date and Place for determination of winner/s:

How winner/s will be decided:

Random electronic draw by a representative of IMB from a computer-generated list of entries. The first valid entry drawn wins.
