Who is the promoter?

The promoter is IMB Ltd trading as IMB Bank – ABN 92 087 651 974, AFSL / Australian Credit Licence 237 391.

How does a person get an entry in the promotion?

A person gets entry to the competition by receiving an email from IMB that provides access to our Member Survey 2019. They then need to complete and submit the Survey and provide their name and contact information to be eligible for the prize draw.

Residents of which State(s) or Territory(s) qualify?

Entry is open to residents of Australia.

What does a person need to do once it is established they are eligible to enter the draw?

Times and dates when entries open and close:
